- 3. The allotment of parlour is purely after verification / scrutiny of feasibility for location and other aspects by the concerned officer.

TERMS & CONDITIONS FOR PARLOURS IN GHMC & DISTRICTS

- 1. The operator has to submit a Demand Draft of Rs.1000/- along with application form which is non-refundable. After getting the approval operator has to pay Rs.5000/- Security deposit for the parlour which is refundable.
- 2. Another Security Deposit of Rs. 5000/- in the form of DD which is refundable towards the vendor deposit applicable only for GHMC area applicants.
- 3. The applicant has to furnish the Demand Draft in favour of MD,TGDDCF LTD payable at Hyderabad.
- 4. In case of open land, the operator has to construct / fabricate the structure at his own cost as per the Federation approved designs.
- 5. The operator has to bear the monthly rentals of the rented premises.
- 6. The products are supplied at retailer's price or any special price as decided by the Federation from time to time. The operator should compulsorily sell liquid milk.
- 7. TGDDCF Ltd will supply Vijaya Telangana Liquid milk on Vendor price.
- 8. All supplies are on Cash & Carry only.
- 9. Operator has to obtain necessary FSSAI, Trade License or any other statutory licenses to run the parlour.
- 10. The branding of the outlet and glow sign board will be provided by the Federation.
- 11. The operator should not sell any other competitive dairy products other than Vijaya (Telangana) dairy products.
- 12. Party has to enter an Agreement with TGDDCF Ltd on Rs.100 Bond Paper.
- 13. Federation will provide cooling unit (if required) by charging 50% cost of the unit i.e., Visi cooler / chest cooler / Deep Freezer based on the availability.
- 14. For sale of Vijaya Telangana branded ice creams will be supplied by the Franchisee / Federation on cash and carry ex-factory basis.
- 15. Customized schemes will be offered to Vijaya Dairy Parlours as and when it is required.
- 16. The operator has to run the parlour for a minimum period of one year compulsory. The refund of the Security deposit shall be made after running the business for a minimum period of one year.
- 17. The operator has to start the business within one month from the date of appointment of the parlour, failing which the allotment order is deemed to be cancelled. Federation reserves the right to allot the same to any other applicant.
- 18. The operator has to intimate the commencement of the operations of the parlour and also provide the sales details on monthly basis to this office.
