## TERMS & CONDITIONS FOR DISTRIBUTIONSHIP IN GHMC & DISTRICTS

- 1. The firm has to submit the Demand drafts of Rs. 2000/- towards application fee which is not refundable.
- 2. Rs.25,000/- towards refundable Security Deposit which does not carry any interest after allotment of Milk Products Distributionship.
- 3. With regard to Liquid Milk Distribution Security Deposit equivalent to two days sales and one day crates value to be deposited with the Federation which does not carry any interest.
- 4. The Demand Drafts to be drawn in favour of MD, TGDDCF Ltd, Hyderabad.
- 5. The firm should have a registered GST & FSSAI License
- 6. The distributor shall lift the stocks on ex-factory basis from MPF, Hyderabad / Mega Dairy / District Milk Sheds / Any other location as specified by the Federation from time to time.
- 7. The Distributor shall place their own insulated transport vehicle and start retailing /distribution of the products in the allotted jurisdiction.
- 8. The firm shall have to give and undertaking on Rs.100 bond paper abiding the terms and conditions.
- 9. Indent has to be communicated in 24 hours advance and lift the stocks on cash and carry basis.
- 10. The distribution shall lift the stocks within one month from the date of allotment of the distributionship
- 11. The Federation reserves the right to appoint more number of Distributor as per the requirement from time to time.
- 12. Federation reserves the right to cancel the distributionship at any point of time without assigning any reasons.
- 13. The firm / applicant should do a business of not less than Rs.25.00 lakhs per month and shall increase the turnover by 10% per annum.
- 14. The operations of the Distributionship should be commenced within one month from the date of allotment of the Distributionship, failing which the allotment order is deemed to be cancelled.
